Profiling Cyber Adversaries and Their Tactics

Cyber threats have become a critical component of our digital world. From state-sponsored hackers to rogue individuals, corporate spies, and organized crime units, these threat actors come in many forms and possess the skills and capacities to wreak havoc on our online infrastructure. Motivated by various objectives, such as financial gain or espionage, threat actors employ a complex array of **Tactics, Techniques, and Procedures (TTPs)** for their attacks. These tactics may include anything from phishing campaigns, malicious software, social engineering, and network intrusions to data manipulation or theft.

In this chapter, we will discuss the motivations and objectives of threat actors and explore some real-world examples of cyber-attacks. We will also look at the different types of TTPs used by threat actors and evaluate measures that can be taken to protect against them. Ultimately, the goal is for you to gain a better understanding of cyber threats and the actions necessary to secure your systems against malicious actors.

- Types of threat actors
- Motivations and objectives of threat actors
- Tactics, Techniques, and Procedures (TTPs)
- Real-world examples of cyberattacks and consequences

Types of threat actors

It is time for the next change in how security professionals approach not only building defenses but best practices for identifying, responding to, sustaining, and recovering from attacks. While, historically, it was all about building preventative defenses and even often assuming that the organization would never be targeted, at one point, it was understood that organizations must continuously assume breaches.

By assuming breaches, organizations prepare for the worst-case scenario because it is acknowledged that it's no longer *if* but *when* they will be targeted. However, now we must go to the next step, assume an attacker's mindset, and anticipate their next move while becoming more resilient. As seen in the following figure, as an industry, it's time to push into the stage of anticipation.




Figure 1.1 – Evolution of cybersecurity mindset

Putting oneself in the attacker's mindset is crucial as it allows for building effective incident response procedures, which can help ensure that all necessary steps are taken immediately following an attack. Furthermore, proactive measures such as implementing robust security controls, conducting continuous threat and vulnerability assessments, training security and end users on cyber hygiene best practices, and regularly testing your incident response plans are essential to any organization's modern cybersecurity strategy. However, all this can only be possible if we deeply understand the threat actors and the landscape. Remember that threat actors are also putting themselves into a defender's mindset and consider how incident response procedures might be modeled, the tooling you might have and how it's configured, and respective **Service-Level Agreements (SLAs)** with stakeholders. As defenders, we must understand who we are against; this will help us prioritize our defense strategy. Just as a chess player must study their opponent's moves to plan a winning strategy, defenders must understand their adversaries to prioritize their defense tactics effectively.

“If you know the enemy and know yourself, you need not fear the result of a hundred battles. If you know yourself but not the enemy, for every victory gained, you will also suffer a defeat. If you know neither the enemy nor yourself, you will succumb in every battle.” — Sun Tzu, The Art of War

Cybersecurity threats can be posed by a group or individual, including nation-state threat actors, hackers, cybercriminals, script kiddies, and **Advanced Persistent Threat (APT)** actors. Each type of threat actor has motivations and objectives in launching attacks against organizations or individuals. First, security professionals must understand the different kinds of threat actor categories so that, in the next step, it's possible to understand the TTPs used to attack systems and the potential consequences should the threat actor be successful. When diving into the different kinds of threat actors, it is critical to understand their unique motives, their available resources, and the methodology they use for their cyber attacks. Not all attacks are equal, and not all security controls will be adequate for all attacks.

Summary of threat actor categories

Threat Actor Categories	Description
Cybercriminals	Cybercriminals engage in cybercrime for financial gain while commonly using ransomware, identity theft, or phishing tactics.
Nation-State Actors	Nation-state actors are state-sponsored groups or individuals that often operate in the shadows and act on behalf of a government, typically seeking to disrupt critical infrastructure, steal sensitive data, or conduct cyber espionage.
Hacktivists or Activists	Hacktivists are cyber activists who use hacking techniques to promote a social or political cause, often targeting organizations or governments they perceive as unjust.
Insider Threats	Insider threats can be current or former employees, contractors, or partners with access to an organization's systems that misuse that access to cause harm, steal information, or commit other malicious acts.
Advanced Persistent Threats (APTs)	Advanced Persistent Threats , or APTs for short, are highly skilled and often well-funded threat actors, who engage in persistent and highly targeted attacks, using sophisticated tactics and techniques to infiltrate and maintain access to systems.
Cyber-Terrorists	Cyber-terrorists can be individuals or groups who use cyber attacks to cause chaos, fear, or physical harm, often driven by religious, political, or ideological motivations.
Script Kiddies	Script kiddies are inexperienced hackers who use readily available scripts or tools to carry out cyber attacks, often without a specific target or objective, seeking to cause disruption.
Private-Sector Offensive Actors (PSOAs)	Private-Sector Offensive Actors (PSOAs) , also commonly referred to as hackers-for-hire, are highly skilled criminals who offer their services to the highest bidder, whether a corporation, criminal, or government organization.

Each type of threat actor presents unique challenges and requires tailored defense, identification, response, and recovery strategies to mitigate the risks they pose effectively. Therefore, let's dive deeper into each of these threat actor types.

Cybercriminals

Cybercriminals continuously hunt for vulnerabilities that can be exploited to gain unauthorized access to sensitive data, often for financial benefits. Cybercriminals manifest in different types, from individual cybercriminals who typically aim to compromise individual accounts to crime syndicates with an extensive global reach. Cybercriminals commonly leverage phishing campaigns, identity theft, and ransomware attacks to steal valuable information or extort money from their victims. As cybercriminals evolve and adapt, cybercriminals employ increasingly sophisticated techniques and tools to compromise security controls and penetrate personal and organizational systems. Some cybercriminals target vulnerable small businesses, while others seek to infiltrate large corporations, government agencies, or critical infrastructure.

Nation-state actors

Nation-state threat actors are among the most feared threat actor categories. The reason is that nation-state actors, the majority of the time, have significant resources to plan and execute large-scale and highly sophisticated cyber attacks. The majority of the threat actor groups that are sponsored by governments or state-affiliated entities operate in the shadows in complete secrecy and aim to steal sensitive information, disrupt critical infrastructure, or conduct cyber espionage operations. It's crucial to not take nation-state actors lightly due to their access to significant resources and vast networks, allowing them to launch massive global campaigns against any target quickly.

Hacktivists

Hacktivists, also called cyber activists, are not a new threat actor category but have existed since 1996. In 1996, **Cult of the Dead Cow (CDC)** members coined the term hacktivism. The CDC was an early hacktivist collective that exposed government secrets and fought for freedom of speech on the internet. Hacktivists use hacking techniques to promote social or political causes. Their victims are organizations and governments that hacktivists deem unjust, to bring attention to their cause.

A hacktivist group example is Anonymous, which has performed several cyberattacks over the years, including an operation against Scientology in 2008 and Operation Payback, which occurred after organizations including PayPal, MasterCard, and Visa imposed blockades on Wikileaks in 2010. In recent years, hacktivist groups have also increasingly performed **Distributed Denial-of-Service (DDoS)** attacks against websites belonging to the United States of America's law enforcement agencies. A recent example is during the massive protests following George Floyd's death. The motivations behind hacktivism vary vastly, depending on which hacktivist group is involved and what cause they stand for. While many hackers are financially motivated, others may be motivated purely by ideological reasons or a desire for justice and revenge.

Insider threats

Insider threats encompass various actors, including current and former employees, partners, contractors, and other trusted insiders with authorized access to corporate systems and sensitive data. Insider threats pose a significant challenge for security professionals, given that insider threats originate from individuals with authorized environmental access. Insider threats deliberately abuse their access privileges to cause damage or steal valuable and often highly classified information.

Furthermore, insider threats are especially dangerous given that these individuals often have intimate knowledge of the organization's policies, procedures, and infrastructure, which they can exploit to bypass security controls and avoid detection. Insider threat tactics are diverse and often insidious, with some actors leveraging social engineering techniques to manipulate their colleagues into granting them further access or revealing sensitive information. This may involve tactics such as impersonating an authority figure or exploiting the trust of fellow employees. By operating covertly, these individuals can carry out their malicious activities undetected for extended periods, potentially causing extensive harm to the organization.

Advanced Persistent Threats (APTs)

Advanced Persistent Threats (APTs) are a threat actor category that can conduct highly sophisticated and systematic cyber-attacks on specific targets, often to steal sensitive information or disrupt operations. APTs often leverage sophisticated techniques, including access to critical software vulnerabilities, unknown to the world, aka zero-days, to infiltrate and maintain access, through persistence, while often evading typical defenses and threat detection tools and processes. Once the APT is inside the target environment, they leverage various tactics, such as creating backdoors, installing keyloggers, and exfiltrating data, often in small batches but frequently to avoid detection. APTs are often well-resourced and highly motivated groups that can remain undetected for months or even years. Given APTs' ability to operate in stealth and establish persistence, it makes them, along with nation-state actors, among the most dangerous cyber threats today, which requires security professionals always to be vigilant and have robust security procedures and tooling in place to defend against them.

While gaining insights about the various APT groups is challenging, security professionals can leverage publicly available libraries such as the one from the MITRE organization, a not-for-profit that provides technical guidance for government agencies and developed the MITRE ATT&CK framework—a comprehensive knowledge base modeling cyber adversary tactics and techniques for threat detection and prevention. Groups

Groups are activity clusters that are tracked by a common name in the security community. Analysts track these clusters using various analytic methodologies and terms such as threat groups, activity groups, and threat actors. Some groups have multiple names associated with similar activities due to various organizations tracking similar activities by different names. Organizations' group definitions may partially overlap with groups designated by other organizations and may disagree on specific activity.

For the purposes of the Group pages, the MITRE ATT&CK team uses the term Group to refer to any of the above designations for an adversary activity cluster. The team makes a best effort to track overlaps between names based on publicly reported associations, which are designated as "Associated Groups" on each page (formerly labeled "Aliases"), because we believe these overlaps are useful for analyst awareness. We do not represent these names as exact overlaps and encourage analysts to do additional research.

Groups are mapped to publicly reported technique use and original references are included. The information provided does not represent all possible technique use by Groups, but rather a subset that is available solely through open source reporting. Groups are also mapped to reported Software used and attributed Campaigns, and related techniques for each are tracked separately on their respective pages.

Russia	APT28	APT28 has been attributed to Russia's General Staff Main Intelligence Directorate (GRU) 85th Main Special Service Center (GTsSS) military unit 26165. In 2016, APT28 reportedly compromised the Hilary Clinton U.S. presidential campaign, the Democratic Congressional Campaign Committee, and the Democratic National Committee to interfere with the U.S. presidential election.
Russia	APT29	APT29 has been associated with Russia's Foreign Intelligence Service (SVR). It is believed that APT29 has been operating since at least 2008, primarily targeting government networks in Europe and NATO member countries, think tanks, and research institutes. In 2021, the US and UK governments attributed the SolarWinds supply chain attack to APT29.
Russia	FIN7	FIN7 is a Russian-based APT group that is financially motivated and has been active since 2013. FIN7 primarily targets hospitality sectors, retail, and restaurants and often deploys malware on point-of-sale (PoS) devices. Since 2020, FIN7 is suspected of having also started running their Ransomware as a Service (RaaS) underground.

It is essential to know that APT groups employ sophisticated TTPs to infiltrate and maintain access to their targets' networks, often going undetected for extended periods. Defending against APT groups requires robust security controls, including continuous monitoring, threat intelligence, and incident response capabilities. Furthermore, it is critical to understand which types of APTs you will want to monitor more closely to ensure alignment in your defenses against them. It's essential to ask yourself, "Which APTs are most likely to target my organization?" and "Which APTs most frequently target my industry and/or segment?"

Cyber-terrorists

Cyber-terrorists' primary charter is to perform cyberattacks that cause chaos, fear, and physical harm for religious, ideological, or political reasons.

Typically, cyber-terrorists target infrastructure systems, including transportation networks or power grids, which allows them to disrupt at a large scale. Occasionally, cyber-terrorists have been confirmed as launching cyberattacks against government entities or private organizations to gain access to sensitive data or extortion. It's essential to be aware that cyber-terrorists usually perform social engineering tactics such as spearphishing emails explicitly designed for high-value targets, from which they later deploy malicious code through web servers or other means of communication.

Script kiddies

Script kiddies are a type of threat actor that lacks technical knowledge and experience. Script kiddies typically use pre-made shelf exploits, malicious tools, and scripts to carry out their attacks rather than developing scripts or toolsets.

Furthermore, script kiddies often have no clear objective or target in mind but, instead, just continuously probe till they find a victim. They may carry out attacks simply for the sake of causing disruption or seeking attention from the media or online communities. However, despite their lack of expertise, it's crucial never to underestimate these attackers as they only need to succeed once, and security professionals must defend against them every single time. Therefore, script kiddies can still threaten organizations and individuals, as their attacks can cause disruption and compromise sensitive data.

Private-Sector Offensive Actors (PSOAs)

Private-Sector Offensive Actors (PSOAs) offer their hacking skills to their highest bidder, which is why they are also commonly called hackers-for-hire. PSOAs offer their services to government agencies, corporations, and criminal organizations. These hackers typically employ advanced TTPs, such as social engineering and malicious software, to infiltrate organizations' networks and extract valuable data. PSOAs can cause significant economic damage if left unchecked; hence, organizations must understand this threat actor's motivations and TTPs to defend against them properly.

As the next step, it's critical to understand the motivations and objectives of the different threat actor categories.

Motivations and objectives of threat actors

Cybercriminals are often motivated by financial gain and use methods including identity theft, phishing, or ransomware. Nation-state actors, on the other hand, pursue geopolitical ambitions through cyber espionage. Cyber-terrorists and hacktivists leverage their criminal skills to promote a specific agenda or inflict damage upon perceived enemies.

As security professionals, it is critical to develop targeted countermeasures that protect valuable assets from potential threats. It always goes back to knowing your enemy to build the best defense strategy. With that, security professionals can assess risk and take the appropriate measures to maintain a secure digital environment. To further illustrate the various motivations and objectives, here's a brief list of examples for each of the threat actor categories:

- **Cybercriminals:** The Carbanak group is a cybercriminal syndicate that has operated since at least 2013. Some security researchers believe that Carbanak might be associated with Cobalt Group and FIN7, as all use the Carbanak malware. The Carbanak group is responsible for stealing over \$1 billion from financial institutions worldwide, using tactics such as spear-phishing emails, malware, and data exfiltration.

- **Nation-state actors:** APT29, a threat actor group associated with Russia's Foreign Intelligence Service (SVR), has targeted various government and private sector organizations, including the **Democratic National Committee (DNC)**, during the 2016 U.S. presidential election.

- **Hactivists:** Anonymous is an organized collective of cyber activists that target organizations and governments they perceive as unjust. Anonymous has launched cyberattacks against various government and corporate entities, including the Church of Scientology, PayPal, and the FBI.
- **Insider threats:** The most prominent case of insider threats to this day is Edward Snowden, a former **National Security Agency (NSA)** contractor who leaked classified information about global surveillance programs, exposing widespread government surveillance practices.
- **Advanced Persistent Threats (APTs):** APT36, a Pakistan-aligned threat actor, expands interest in the Indian Education Sector. Security researchers at SentinelLabs discovered that APT36 has been introducing OLE embedding into its typically used techniques for staging malware, from lure documents and version changes to the implementation of Crimson RAT, indicating the ongoing evolution of APT36's tactics and malware arsenal.

- **Cyber-terrorists:** The Cyber Caliphate, a group claiming affiliation with ISIS, has conducted cyberattacks against media organizations, government websites, and social media accounts, spreading propaganda and promoting terrorist activities.
- **Script kiddies:** In 2000, a 15-year-old Canadian hacker known as “Mafiaboy” launched a series of high-profile DDoS attacks against major websites such as Yahoo!, eBay, and Amazon, causing widespread disruption and significant financial losses.

- **Private-sector offensive actor (PSOA):** HackingTeam was an Italian company that provided offensive intrusion and surveillance software to governments, law enforcement agencies, and corporations. They have been criticized for selling their services to authoritarian regimes, enabling surveillance and monitoring of dissidents and political opponents.

Tactics, Techniques, and Procedures (TTPs)

Tactics, Techniques, and Procedures (TTPs) represent the modus operandi of threat actors as they engage in cyberattacks or other malicious activities. These TTPs provide a structured framework for understanding and categorizing the behavior and methods employed by threat actors, enabling

cybersecurity professionals to identify patterns, anticipate threats, and develop adequate security controls and, ultimately, a robust information security program. Security professionals need to comprehend the TTPs employed by threat actors as it will help to identify patterns, anticipate threats, and develop tailored countermeasures. Tactics refer to an attack's overarching goals or objectives, such as data exfiltration or gaining unauthorized access. Threat actors utilize various techniques to achieve their tactics, including exploiting software vulnerabilities, launching social engineering attacks such as phishing, and executing malware attacks.

The MITRE ATT&CK Framework is a comprehensive knowledge base and model for threat actor behavior and their TTPs. This framework is one of the most widely used and comprehensive TTP frameworks in the cybersecurity industry, and today, many security teams use it as their primary resource for TTPs. Given the significance of the MITRE ATT&CK Framework, it is critical to understand it better. The framework is developed by MITRE, which is a not-for-profit organization. The ATT&CK Framework (for Adversarial Tactics, Techniques, and Common Knowledge) provides an in-depth understanding of the TTPs employed by threat actors across various stages of a cyberattack. By compiling this information in a structured manner, the framework enables security professionals to analyze, anticipate, and defend against a wide range of cyber threats.

The ATT&CK Framework is organized into a series of matrices that cover different aspects of the cyber threat landscape, such as Enterprise, ICS (Industrial Control Systems), and Mobile. Each matrix is divided into tactics, which represent the high-level goals of an attacker, and techniques, which are the methods or approaches used to achieve these goals. Within each technique, there are sub-techniques that provide further granularity and detail about specific adversary actions. One key aspect of the MITRE ATT&CK Framework is its focus on the entire lifecycle of a cyberattack. The framework consists of several stages: initial access, execution, persistence, privilege escalation, defense evasion, credential access, discovery, lateral movement, collection, command and control, and exfiltration. Understanding the MITRE ATT&CK Framework can help security professionals build their threat intelligence program and improve their incident response, security posture, security operations, red teaming, and vulnerability management abilities.

Besides the MITRE ATT&CK Framework, MITRE also provides the MITRE ATT&CK Evaluations, a comprehensive assessment of security products and services against real-world cyber threats. These evaluations can help security professionals better understand which security products and services best suit their organizations' needs and avoid falling for false vendor marketing claims. This independent evaluation measures the performance of cybersecurity products and services in detecting, preventing, and responding to sophisticated attack scenarios that are modeled after TTPs used by advanced threat actors. 


Figure 1.3 – MITRE ATT&CK Enterprise Evaluations




Figure 1.4 – SentinelOne’s participation card on the MITRE ATT&CK Evaluation website

Furthermore, the ATT&CK Evaluation fosters an environment of continuous improvement among security vendors as they strive to refine their offerings based on the insights gained from the evaluation process. By leveraging the MITRE ATT&CK Evaluation, organizations can better understand the

strengths and weaknesses of their security infrastructure, ultimately leading to more effective strategies and a heightened level of protection against evolving cyber threats.

In addition to understanding the different threat actor categories and their motivations, objectives, and commonly used TTPs, it is essential to dive deeper into some real-world cyber-attack examples as it will provide security professionals with needed guidance when considering one's defenses.

Real-world examples of cyberattacks and consequences

This section discusses real-world examples of cyberattacks attributed to nation-state actors, APT groups, and other malicious entities such as cybercriminals.

Nation-state actors: NotPetya attack (2017)

Sandworm, which is an APT group attributed to Russia's General Staff Main Intelligence Directorate (GRU) Main Center for Special Technologies (GTsST) military unit 74455, executed a highly destructive cyberattack known as NotPetya, which targeted various organizations across the globe and resulted in damages that exceeded \$10 billion. Although NotPetya initially appeared as a ransomware campaign, it was later discovered that the primary goal was not financial gain but widespread disruption and destruction. Security researchers confirmed that NotPetya was wiper malware designed to irreversibly corrupt and overwrite data on infected systems. It is believed that NotPetya was executed by Sandworm due to the ongoing conflict between Russia and Ukraine. The following diagram provides insights into NotPetya's attack kill chain.




Figure 1.5 – NotPetya Attack Kill Chain

It is possible to identify several MITRE ATT&CK TTPs as part of the NotPetya cyberattack:

- T1190: Exploit Public-Facing Application (EternalBlue and EternalRomance were used to exploit SMB vulnerabilities in Windows)
- T1210: Exploitation of Remote Services (NotPetya leveraged SMB vulnerabilities to spread laterally across networks)
- T1003: OS Credential Dumping (Mimikatz was used to extract credentials from the memory of infected systems)
- T1078: Valid Accounts (Stolen credentials were used for lateral movement and further system access)
- T1485: Data Destruction (NotPetya overwrote and corrupted files, resulting in irreparable data loss)
- T1490: Inhibit System Recovery (The malware modified the MBR, preventing systems from booting up and complicating recovery efforts)
- T1193: Spearphishing Attachment (NotPetya was initially delivered via a malicious email attachment in a software update for Ukrainian tax software)

Nation-state actors: SolarWinds supply chain attack

Discovered in December 2020, the SolarWinds supply chain attack was a highly sophisticated and far-reaching cyber espionage campaign that targeted government agencies and private companies worldwide. The SolarWinds attack is believed to be linked to APT29, a nation-state threat actor related to the Russian Foreign Intelligence Service (SVR). This attack compromised the software development infrastructure of SolarWinds, from which the threat actor could insert a backdoor, known as “SUNBURST,” into a legitimate update of the SolarWinds Orion platform that was then distributed to thousands of SolarWinds customers. With this approach, the threat actor could gain remote access to the networks of organizations that installed the compromised update. Its victims included the U.S. Departments of Treasury, Commerce, and Homeland Security and private sector companies such as Microsoft. The following diagram is a visual aid to better understand the kill chain.




Figure 1.6 – SolarWinds attack kill chain

The SolarWinds supply chain attack involved several TTPs that can be mapped to the MITRE ATT&CK Framework. Some of the critical TTPs associated with the attack include the following:

- T1195.002: Supply Chain Compromise: Compromise Software Supply Chain (The attackers compromised the SolarWinds Orion platform update by inserting the SUNBURST backdoor)
- T1059: Command and Scripting Interpreter (The SUNBURST backdoor executed commands on the compromised systems)
- T1547: Boot or Logon Autostart Execution (The SUNBURST backdoor established persistence by creating a scheduled task that started when the system booted or the user logged in)
- T1134: Access Token Manipulation (The attackers leveraged the permissions of the SolarWinds Orion platform to escalate their privileges on the compromised systems)
- T1070: Indicator Removal on Host (The attackers removed forensic artifacts and logs to hide their activities)
- T1027: Obfuscated Files or Information (The SUNBURST backdoor employed various obfuscation techniques to evade detection)
- T1003: OS Credential Dumping (The attackers accessed credentials from the compromised systems to facilitate lateral movement)
- T1087: Account Discovery (The attackers gathered information about user accounts on the compromised systems)
- T1016: System Network Configuration Discovery (The attackers obtained network configuration information to understand the target environment better)
- T1021: Remote Services (The attackers used remote services such as SMB and RDP to move laterally across the target network)

- T1114: Email Collection (The attackers accessed the email accounts of targeted organizations to collect sensitive information)
- T1005: Data from Local System (The attackers collected data from the compromised systems)
- T1041: Exfiltration Over C2 Channel (The collected data was exfiltrated to the attackers' command and control servers)

Cybercriminals: WannaCry ransomware attack (2017)

The WannaCry attack has been attributed to Lazarus Group which is a nation-state threat actor group from North Korea's Reconnaissance General Bureau department. WannaCry seems to have two primary objectives: to cause chaos and, secondly, to achieve financial gain. WannaCry was a ransomware attack in May 2017 and a large-scale global campaign that impacted over 200,000 endpoints across 150 countries. WannaCry targeted Microsoft Windows-based endpoints and encrypted users' files, demanding a ransom payment in Bitcoin to exchange the decryption key. The rapid and widespread nature of WannaCry led to significant disruptions in various sectors, including healthcare, finance, and logistics, causing an estimated economic loss of several billion dollars.

WannaCry leveraged the EternalBlue exploit, which targeted a vulnerability in the Windows **Server Message Block (SMB)** protocol. Like NotPetya, the NSA initially discovered the EternalBlue exploit and later leaked it by the Shadow Brokers. The exploit enabled the ransomware to spread rapidly across networks, infecting vulnerable systems without user interaction. Microsoft released a patch for the vulnerability (MS17-010) in March 2017, and many organizations had not yet applied the update, leaving their systems exposed to the attack. The following diagram visually helps to better understand the kill chain.




Figure 1.7 – WannaCry attack kill chain

Here's how the WannaCry attack can be mapped to MITRE ATT&CK TTPs:

- T1190: Exploit Public-Facing Application (EternalBlue was used to exploit the SMB vulnerability in Windows)
- T1486: Data Encrypted for Impact (WannaCry encrypted users' files, demanding a ransom payment for decryption)
- T1210: Exploitation of Remote Services (WannaCry leveraged the EternalBlue exploit for rapid propagation and lateral movement)
- T1490: Inhibit System Recovery (Victims were instructed to pay the ransom in Bitcoin to receive the decryption key)

Cybercriminals: Colonial Pipeline ransomware attack

The Colonial Pipeline ransomware attack was a high-profile cyber incident that took place in May 2021. The attack targeted the Colonial Pipeline, the largest fuel pipeline in the United States. The ransomware attack, carried out by a cybercriminal group known as DarkSide, encrypted the company's IT systems and demanded a ransom payment in exchange for the decryption key.

In response to the attack, Colonial Pipeline shut down its pipeline operations to prevent the ransomware's spread and ensure its systems' safety. This decision led to widespread fuel shortages and a temporary spike in fuel prices throughout the United States. Eventually, the company paid the attackers a ransom of approximately \$4.4 million in Bitcoin to regain access to its systems.

The Colonial Pipeline attack highlights the increasing threat of ransomware attacks against critical infrastructure and the potential cascading effects these attacks can have on society. The incident also underscores the importance of robust cybersecurity measures and incident response plans for organizations in every sector. The following diagram showcases the kill chain.




Figure 1.8 – Colonial Pipeline attack kill chain

Here’s how the Colonial Pipeline attack can be mapped to MITRE ATT&CK TTPs:

- T1486: Data Encrypted for Impact (DarkSide ransomware encrypted the company’s IT systems, demanding a ransom payment for decryption)
- T1490: Inhibit System Recovery (The company paid the ransom in Bitcoin to regain access to its systems)
- T1566: Phishing (DarkSide is known to use phishing emails as an initial infection vector, though the exact method used in the Colonial Pipeline attack is unclear)
- T1003: OS Credential Dumping (DarkSide ransomware often attempts to steal credentials from the compromised systems)

The former identifies potential points of exploitation in a system or network, while the latter simulates cyberattacks to test resilience. Risk assessments quantify or qualify the potential impacts of identified vulnerabilities. It's a crucial process that enables an organization to understand the consequences of exploited vulnerabilities and facilitates better decision-making around cybersecurity investments and strategies.

Post-assessment, it's crucial to prioritize and remediate weaknesses, which involves developing and executing a mitigation plan. Prioritization typically depends on factors including the criticality of the system, the potential impact of a breach, and the exploitability of the vulnerability.

By adhering to these practices, organizations can build a more resilient cyber defense system, ensuring business continuity and integrity of their information assets.



Understanding organizational weaknesses and vulnerabilities

Understanding the differences between organizational weaknesses and vulnerabilities is paramount to forming an effective cybersecurity strategy. Moreover, human-based vulnerabilities such as employee unawareness can open an organization to social engineering attacks. Types of organizational weaknesses




Outdated hardware or software (e.g., firmware, operating systems, applications, etc.) that are not patched and secured or systems incorrectly configured can be a major security issue. For example, operating systems running older software versions without the most recent security updates can cause significant problems for computer users and networks. Ensuring all components are up to date with the latest security patches is essential for protecting against technical weaknesses. Additionally, all hardware installations should be securely implemented and network endpoints adequately protected to avoid potential vulnerabilities.</p>
	<p>Process: Organizations need adequate security policies and well-defined change management processes. Without which the organizations are left vulnerable to various threats. This could be anything from inadequate backup procedures to an insufficient incident response strategy in the event of a ransomware attack. While organizations must be prepared for such disasters, they need more than just a robust disaster recovery plan; they need to ensure they have the necessary protocols and procedures to respond quickly and effectively to potential incidents.</p>

	<p>Human: Humans are prone to mistakes, a fact that can lead to security incidents. This can be due to personnel lacking cybersecurity education, leaving them vulnerable to social engineering techniques such as phishing scams. It is also possible for insiders, whether by malicious intent or accident, to unwittingly cause significant security breaches. To prevent this, organizations must prioritize educating their staff on cybersecurity protocols and strategies and ensuring strict regulations are in place.</p>

While these categories help structure our understanding of weaknesses, it's essential to remember that they often interact. For instance, a technical weakness can be exploited due to a process weakness (such as a lack of patch management) facilitated by a human weakness (perhaps clicking on a phishing link). This interconnectedness makes addressing all weaknesses vital to a comprehensive cybersecurity strategy.

Types of organizational vulnerabilities

Let's look closer into what types of organizational vulnerabilities exist. Similar to organizational weaknesses, there are many variations. We can categorize them into software, hardware, and network vulnerabilities. Let's explore these categories and consider practical examples to understand them better.

	<p>Software vulnerabilities: This type of vulnerability allows malicious actors to break into a system and cause harm. To prevent such threats from occurring, it is critical to ensure that all applications are up-to-date with the latest security patches and fixes. As an example, in 2017, the WannaCry ransomware attack exploited a flaw in Microsoft's Server Message Block protocol that, if not patched, could have allowed an attacker to access the system. WannaCry is suspected to have spread to 150 countries, and the cybercrime caused an estimated \$4 billion in losses across the globe.</p>
	<p>Hardware vulnerabilities: These are weaknesses in the physical components of a system that can lead to data leakage and theft. In 2018, two major hardware security flaws, Spectre and Meltdown, were discovered to affect modern AMD, Intel, and ARM processors. These vulnerabilities allowed malicious programs to access sensitive information stored in the computer's processor by exploiting its speculative execution feature. As a result, virtually all devices running on these processors were vulnerable to attacks.</p>
	<p>Network vulnerabilities: Vulnerabilities in network architecture and protocols can make systems susceptible to malicious attacks if configurations are left unsecured. For example, a Wi-Fi network that has not been adequately secured with encryption could easily be accessed by attackers, who can intercept traffic and steal confidential information.</p>

As security professionals, it is crucial to be aware of the organization's environment's vulnerabilities. Knowing how these security flaws can be utilized maliciously is essential in implementing effective defensive techniques. Organizations should prioritize practices such as patching software regularly and ensuring secure configurations when it comes to network settings, as these measures can significantly reduce the chances of an attacker successfully exploiting a vulnerability.

Real-world examples

The global logistics company Maersk experienced a cyberattack in 2017 called NotPetya, triggered by a software vulnerability in their accounting software. This cyberattack resulted in the shutdown of 76 port terminals worldwide, taking Maersk two grueling weeks to restore its systems and costing an estimated \$300 million.

Similarly, the 2017 Equifax breach compromised the sensitive data of approximately 147 million consumers when attackers exploited an unpatched Apache Struts web application vulnerability. This incident incurred major reputational damage and legal repercussions, with a whopping \$575-million settlement.

The 2020 SolarWinds hack further highlighted the consequences of supply chain weaknesses, as hackers infiltrated SolarWinds' software development process and inserted a backdoor into an update for over 18,000 customers.

These examples demonstrate that managing organizational weaknesses and vulnerabilities is essential to mitigating damage and avoiding hefty costs. As such, it is crucial to maintain robust security protocols across all digital supply chain points and build an effective cybersecurity framework that promptly identifies, assesses, and remediates any vulnerabilities.

This is an essential lesson for all organizations to remember—the cost of not adequately addressing weaknesses and vulnerabilities can be immense. Organizations must prioritize the development of secure software solutions, protecting their digital supply chain, and mitigating human vulnerabilities to protect themselves from future cyberattacks.

Security audits




Figure 2.1 – Step-by-step vulnerability assessment process

Automated scanning involves running specialized tools, such as commercial software (e.g., Tenable Nessus, Qualys, or Rapid7 Nexpose) or open source products against databases of known vulnerabilities such as the **Common Vulnerabilities and Exposures (CVE)** list. These tools generate reports with details about the detected vulnerabilities and the recommended remediations.

Manual reviews involve security professionals thoroughly reviewing systems and processes to identify potential weaknesses that automated tools may miss. Due to the automation, additional vetting may be required to perform the next level of risk assessment and false-positive review to minimize the impact on operations. As part of this review, additional inputs from threat intelligence sources, targeted system threat landscapes, and system criticality could enhance the efficiency of the risk assessment process.

Once vulnerabilities are identified, they must be prioritized according to their severity, the sensitivity of the affected system, and the potential impact of a breach. This is an essential step, as it's important to acknowledge that there will always be vulnerabilities. At the same time, regardless of the organization's size, we always need to prioritize the workload. Another model is **DREAD** (short for **D**amage **P**otential, **R**eproducibility, **E**xploitability, **A**ffected **U**sers, and **D**iscoverability). This model quantifies each threat's risk level to prioritize mitigation efforts.

Affected users	How many users could be impacted?
Discoverability	How easy is it to discover the attack?

The **Process for Attack Simulation and Threat Analysis (PASTA)** model is a more complete seven-step process combining threat identification and risk assessment.




Figure 2.3 – The seven stages of the PASTA model

The best way for an organization to embrace threat modeling is by creating a proactive security culture. Teams should be encouraged to continuously monitor their systems and look for potential threats, such as new vulnerabilities or malicious actors. This approach allows organizations to stay on top of the rapidly changing digital threat landscape and defend against cyberattacks more effectively.

Penetration testing

Penetration testing, more commonly known as ‘pen testing,’ is an authorized and proactive method of identifying security vulnerabilities in a system by simulating a cyberattack. Whereas vulnerability assessments are used to identify weaknesses, penetration tests go one step further by actively attempting to exploit these weaknesses to assess the potential damages should there be a breach.

Pen tests can come in many forms, including black-box testing, which mimics an external attacker without any prior knowledge of the system; white-box testing, which replicates an insider attack with a comprehensive understanding of the system; and grey-box testing, which is a combination of the two and provides a balanced approach to detecting potential vulnerabilities.

Once completed, a penetration test wraps up by creating a detailed report outlining all discovered vulnerabilities, the data accessed, and the recommended remediation actions. Tools that are highly popular when carrying out pen tests include Metasploit for developing and executing exploit code against target machines and Burp Suite for web application security tests.




Figure 2.4 – Burp Suite, a tool used for web application security testing

Conducting regular penetration tests provides organizations with validation of their security controls, plus the ability to uncover hidden threats before they become too serious. It is an essential aspect of any strong cybersecurity program and ensures that systems remain resilient from attacks while preparing companies for real-world threats.

Social engineering tests

Social engineering tests are a vital tool for determining the potential vulnerabilities that stem from an organization's human-centric components. These tests simulate various social engineering attacks to evaluate the extent of employees' observance of security protocols.

The most common type of test is a phishing simulation, which involves sending malicious emails to employees to assess their ability to recognize and report attacks.




Figure 2.5 – Phishing simulation example

Other social engineering tests include pretexting tests, which occur when an attacker fabricates a false scenario to acquire confidential information or unauthorized access to systems. Impersonating an IT support person who requests a password reset is one example of such a deception.

Tailgating tests examine the effectiveness of physical security measures while also testing employees' adherence to these principles by attempting entry into restricted areas by following authorized personnel after creating some sort of urgency or relying on politeness.

Baiting tests use malicious devices, such as USB drives, as bait that curious employees may unknowingly plug into a computer and inadvertently install the malware.

The results from social engineering tests are highly beneficial to understanding how humans influence an organization's security posture. Through these assessments, areas where employees require additional training and awareness can be identified and highlighted, illustrating that strong cybersecurity is not just about technology but also people and their decisions. Such tests further emphasize the need to cultivate a security-first culture within any organization since humans are the weakest link in any cybersecurity defense strategy.

Social engineering tests are essential to any organization's security system. They play a significant role in determining the weak points of an organization's human-centric defenses and can help identify areas where further training and awareness are needed. Ultimately, these tests serve as vital tools for uncovering potential vulnerabilities that may arise from human error or negligence.

Conducting risk assessments

- **Operationally Critical Threat, Asset, and Vulnerability Evaluation (OCTAVE):** OCTAVE emphasizes the engagement of stakeholders in the process and focuses on organizational risk by assessing critical assets, potential threats, and vulnerabilities, analyzing impact levels, and developing effective mitigation strategies.

To ensure the effectiveness of any chosen methodology, its implementation needs to be tailored accordingly, considering the industry-specific and organizational requirements such as regulatory compliance and available resources. With the help of an adequate risk assessment methodology applied consistently, an organization can bolster its security posture substantially, thereby mitigating possible losses due to security incidents.

Identifying assets and establishing the scope




Figure 2.6 – Risk assessment example template




Figure 3.2 – Sony Attack kill chain




Figure 4.2 – NIST Cybersecurity Framework




Figure 4.3 – Mandiant Advantage Threat Intelligence




Figure 4.4 – Example workflow of incident response plan




Figure 4.5 – Cybersecurity mesh example

As a risk assessment identifies vulnerable systems and potential threats, the infamous Sony Pictures hack of 2014 might have been mitigated or even prevented with a thorough risk assessment.

Continuous monitoring and auditing have become non-negotiable. As an example, adequate monitoring could have detected unusual activity earlier, in J.P. Morgan's 2014 breach, when hackers accessed data for 83 million accounts, and it continued to be undetected for 2 months. Had this principle been applied, the breach's impact could have been drastically reduced.

Technical tools, from firewalls to encryption protocols, are like the shields and barriers of a fortress. But the human component – through training and awareness – is equally significant. The 2016 Podesta email leak serves as a stark reminder that proper training and awareness could have avoided the wide-reaching consequences of a simple phishing attack.

Emphasizing the importance of regular software updates and patches, we only need to recall the WannaCry attack's impact on systems running outdated Windows versions. Clear policies and guidelines, meanwhile, act as a compass, guiding behaviors. When companies have swift response policies potential damage can be minimized, such as the ones affected by the Cloudbleed bug in 2017.

In sum, a cybersecurity strategy is not just about having the right tools or tactics in place but rather about having an integrated approach where real-world lessons inform principles, processes, and actions. With a solid foundation, organizations can better navigate the tumultuous seas of cybersecurity, ensuring not only their survival but also their success.

This chapter discussed various aspects of effective collaboration, such as establishing trust, upholding confidentiality, utilizing collective intelligence to boost security measures, and encouraging shared responsibility. It began by highlighting the benefits of shared awareness and the collective improvement of capabilities. It also touched upon the skills for participation in threat intelligence platforms and frameworks to take a proactive approach against evolving cyber threats.

Furthermore, it explored the principles of collaboration, underscoring trust and confidentiality as essential foundations. The significance of agreements and secure communication practices was emphasized. This chapter covered skills such as creating and enforcing disclosure agreements, implementing encryption methods, and employing classification frameworks such as the TLP to protect shared data.

Additionally, it demonstrated how actionable intelligence could enhance security operations by improving threat detection, incident response strategies, and vulnerability management. Practical examples were provided to showcase the advantages of incorporating shared intelligence into procedures, from optimizing alert systems to prioritizing patching activities based on real-time threat insights. The skills you acquired included configuring SIEM systems with threat feeds, conducting vulnerability assessments, and participating in incident response initiatives.

This chapter underscored cybersecurity's importance as an effort beyond cybersecurity teams. It stressed the significance of education in promoting a security culture and the advantages of collaborations between private sectors to build robust cyber resilience. The key takeaways from this section involved developing and executing cybersecurity awareness initiatives, participating in partnerships between the private sectors, and using technology to encourage a shared sense of responsibility for cybersecurity.




